# FY 2021-22 county budget and tax rate approved

On April 19th, the Board of Supervisors approved its FY 2022 budget of \$211.3 million, effective as of July 1. The real estate tax rate remains 89 cents per \$100 assessed value, and personal property taxes remain at \$2.55.

## **County addresses broadband infrastructure and service**



In the summer of 2020, Montgomery County partnered with Gigabeam and Thompson & Litton to address areas in the county that are underserved and unserved by broadband. On Mar. 18, 2021, Montgomery County was awarded a Virginia Telecommunication Initiative (VATI) grant to improve broadband infrastructure. Montgomery County is adding \$140,763 and Gigabeam is also adding \$140,763 to the \$919,569 VATI grant to extend our broadband network, bringing the total investment to \$1,201,095. In addition, Gigabeam has pledged to match \$206,540 as in-kind matching funds for resources to include labor and equipment use, design, and fiber connections/routers.

The extended broadband network will bring fixed wireless broadband access to 1,292 serviceable units, including 44 businesses in Allegheny Springs, Elliston, Lafayette, and Shawsville. Construction will begin this summer, with anticipated completion by the summer of 2022. To stay informed on broadband updates in the county, visit *www. montva.com/broadband* 

#### New recreation, workspace, and storage areas under construction



Construction on Creed Fields Park (pictured) in the Elliston/Shawsville area will be completed by this summer. The park will include four fields for football, lacrosse, soccer, baseball, softball, coach pitch and t-ball; bathrooms; a playground; a shelter; and a walking path.

Creed Fields Park was named after long-time Board of Supervisor member Gary Creed, who represented Eastern Montgomery from 2002-2018. The estimated cost for this project is \$2.5 million.

In February, construction began on four buildings behind the Montgomery County Government Center. The purpose of these buildings is to provide workspace and storage for the county's field crews within buildings and (*Continued on next page*)

grounds, the garage, and the Public Service Authority (PSA). The General Services building is 13,439 square feet and will house a garage for vehicle repairs; buildings and grounds office area and workshop; office and repair areas for lawns and landscaping and Parks and Recreation field crews; and a solid waste collections equipment storage area. The PSA building is slated to be 4,324 square feet and will include office space for field crews; a repair shop; and a materials storage area. The other two facilities, salt shed and equipment storage shed, 875 and 7,000 square feet, respectively, will be used for storage.

The estimated construction cost for these facilities is \$5 million, with an anticipated completion date of summer 2022.

#### Lifetime dog licenses available

As of Nov. 2020, Montgomery County began issuing lifetime animal licenses for individual dogs four months or older. To purchase this \$25 lifetime dog license, present your dog's original valid rabies vaccination certificate at either the Montgomery County Treasurer's Office; the Montgomery County Animal Care and Adoption Center; or the Blacksburg Municipal Building. Or, you can purchase by mail through the Montgomery County Treasurer's Office. An individual lifetime tag will be valid as long as the rabies vaccination is up-to-date.
