Montgomery County Response: Proposals should include proof of insurance coverage that meets the required dollar amounts of the RFP. Selected firms will be required to provide certificates of insurance as part of the award process, naming each entity contracted with (Montgomery County, PSA, and/or MCPS), as additional insured.

4. **Question:** As we are putting together our team, we wanted to confirm the County's intent for the request.
