## PETITION FOR RECOUNT OF BALLOTS FOR THE OFFICE OF MAYOR FOR THE TOWN OF BLACKSBURG

Peter Macedo, by counsel, hereby appeals the Montgomery County Electoral Board's certification of the November 4, 2025, General Election results declaring Michael D. Sutphin the prevailing candidate in the election for Mayor of the Town of Blacksburg, and requests that this Court "have the ballots in the election recounted," pursuant to Virginia Code §§ 24.2-800, et seq. Virginia Code § 24.2-801(B). In support of this Petition, Macedo states the following:

- 1. Peter Macedo (Macedo) was a candidate for Mayor for the Town of Blacksburg in the November 4, 2025, General Election.
  - 2. Macedo was one of two (2) candidates for Mayor on the ballot.

- The Montgomery County Electoral Board certified the results of the Mayoral election on November 14, 2025.
  - 4. The certified results are:

Michael D. Sutphin (Sutphin)	5,573
Peter Macedo	5,555
Write In	164

- 5. According to the certified results, Sutphin received the most votes, besting Macedo by 18 votes: the Electoral Board certified Sutphin as winner of the election. *Id.*
- 6. The Code of Virginia provides that "the defeated candidate may appeal from the determination of ... the electoral board for a recount of the vote as set forth in this article," when there exists "a difference of not more than one percent of the total vote cast for the two such candidates as determined by ... the electoral board[.]" Virginia Code § 24.2-800(B).
- 7. "[O]ne percent of the total vote cast for the two such candidates" is 303.83 (i.e., 5,573 + 5,555, =  $11,128 \times 0.01 = 111.28$ ). Id.
- 8. The difference between the votes cast for Sutphin and for Macedo, 18, is less than 111.28. Therefore, the "difference [is] not more than one percent of the total vote cast for the two such candidates as determined by ... the electoral board,"

thereby entitling Macedo to "appeal from the determination of ... the electoral board for a recount of the vote." *Id.* 

- 9. The Code of Virginia provides further that, when "between the candidate apparently ... elected and the candidate petitioning for the recount [there is] a difference of not more than one-half of one percent of the total vote cast for the two such candidates as determined by the ... electoral board prior to the recount," then the "[c]osts of the recount shall be assessed against the count[y] ... comprising the election district." Virginia Code § 24.2-802.3(A).
- 10. "[0] ne half of one percent of the total vote cast for the two such candidates" is 55.64 (i.e.,  $11,128 \times 0.005 = 55.64$ ). *Id*.
- 11. The difference between the votes cast for Sutphin and for Macedo, 18, is less "than one-half of one percent of the total vote cast for the two such candidates," (i.e., 18 < 55.64). *Id.*
- 12. Therefore, the "[c]osts of the recount shall be assessed against the count[y] ... comprising the election district," *i.e.*, Montgomery County, Virginia. *Id.*
- 13. This Petition is filed within 10 days of the "day ... the electoral board certifie[d] the result of the election ... ." Virginia Code § 24.2-801(A).

WHEREFORE, Peter Macedo petitions this Court to order that:

- A. The ballots in the November 4, 2025, General Election for the office of Mayor of the Town of Blacksburg be recounted; and
- B. The "[c]osts of the recount shall be assessed against" Montgomery

  County, Virginia and not against Macedo, pursuant to Virginia Code §

  24.2-802.3(A).
